### 2. **Next Steps Check In**

Action items and next steps were reviewed from previous meetings. Many items have been completed and an updated next steps document will be sent out after this meeting with action items to be completed by board members.

### 4. **Amalgamation Update & Plan for the January 10th Vote**

-AM: Ilderton, North Middlesex and Lucan had a recap meeting after all organizations held the information nights.

- In January, all organizations will have their vote nights

- North Middlesex: Tuesday, January 9<sup>th</sup>
- Ilderton: Wednesday, January 10<sup>th</sup>
- Lucan: Thursday, January 11<sup>th</sup>

-All organizations will release the results of their vote on Friday, January 12<sup>th</sup>.

-Ilderton will look into having a third-party group to count the ballots for IMHA vote night.

-AM has reached out to South Oxford, who recently went through the reorganization process, to gather information about start-up costs and other inquiries that came up during the information sessions.

- OMHA has lawyers that will be utilized, so there is no fee for a lawyer in the process. New jerseys will be paid for in 'A' level player registration fees.

-The frequently asked questions package will updated to answer questions that came up at the information sessions.

-Year 1 of the program will have a minimum of 204 players able to play for the new A center.

**-Reorganization Vote Day: Wednesday, January 10<sup>th</sup>: 6:00pm – 10:00pm**

-There is a 4-hour window to allow teams that play that night the opportunity to attend the vote.

-All U5-U7 players and OMHA U9-U18 players are given 1 vote per household.

### 5. **Minimum Officiating Requirements**

-BS: There has been a request from coaches for the OMHA U11 and U13 season play. When Ilderton plays Ilderton, there should be a Level 2 referee scheduled to officiate these games.
